Sub: Proposal for extension of Notification in c/w imposing speed limit for 60 (sixty) more days w.e.f. 30.08.2022 on the roads of Barasat-Hasnabad Taki State Highway (SH-2), Basanti State Highway (SH-3A), Basirhat Swarupnagar Road, Old Sakhira road, Basirhat Kalinagar Road and Itinda Road all of under Basirhat Police District.

This is to bring your kind attention that as per the order under above reference (copy enclosed) Notification regarding imposing 60 days speed limit on the identified Black Spots/Vulnerable stretches is going to expire on 29.08.22 in Basirhat PD. In order to prevent road Traffic accidents owing to over speeding, overtaking of vehicles and also to maintain smooth vehicular Traffic system within the jurisdiction of Basirhat PD, regulation for 60 more days is expected/needed w.e.f 30.08.2022.

In view of the above grounds, you are hereby requested to take necessary action for imposing Speed Limit extending to 60 more days w.e.f. 30.08.2022 on the roads of aforementioned stretches / vulnerable places in an urgent basis. Thereafter, necessary direction is to be conveyed upon the concerned authority (PWD / other competent authority) for putting up Speed Limit Signage according to the class of vehicle on different roads for effectively enacting Motor vehicle law in Basirhat PD.

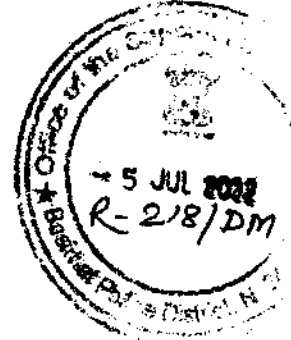

### NOTIFICATION

Whereas, the Superintendent of Police, Basirhat Police District, North 24-Parganas vide his Memo No. 239/TRF(BHT) dated 24-06-2022 has proposed for extension of imposing speed limit restriction and regulation of movement of vehicles in order to prevent Road Traffic Accidents owing to overspeeding and overtaking of vehicles and also to maintain smooth vehicular traffic system within the jurisdiction of Basirhat Police District for 60 days w.e.f. 30-06-2022.

Hence, in exercise of the power conferred upon me under Section 112/115/116 of Motor Vehicles Act, 1988 read with Section 4(1) of West Bengal Traffic Regulation Act (West Bengal Act-XV of 1965), I, Sharad Kumar Dwivedi, IAS, District Magistrate, North 24-Parganas do hereby impose restriction and regulation of movement of vehicles on the major roads and arterial roads as noted below for 60 days w.e.f. 30-06-2022 in the interest of public safety and convenience.
