Whereas, information received from Executive Engineer, Barrackpore Division, PWD, vide his office memo no - 594 dated 10.08.2020, to the effect that while experiencing some abnormal vibrations of the Barrackpore ROB and hence RITES been entrusted with the thorough health check-up of the said ROB, on 06.08.2020, this has been reported by RITES that the condition of the said ROB is not suitable for plying of heavy loaded vehicles due to some major cracks and voids found during their inspection with MBIU. This has also been reported that allowable traffic load on the ROB is up to 10.00 MT (Gross Vehicular Weight).

And, whereas it is necessary in the interest of public safety and also to prevent danger, obstruction, inconvenience to public, in order to impose traffic restriction for regulating the movement of any vehicle beyond the allowable load limit of 10.00 MT (Gross Vehicular Weight) towards Barrackpore ROB from any road under Barrackpore Police Commissionerate.

In exercise of powers conferred upon me under Sections 115,117,122 &126 M.V. Act 1988 and under Sub-Section(1) of Section (4) of West Bengal Traffic Regulation Act, 1965 (WB Act XV of 1965), read with Govt. of West Bengal Home (Transport) Department Order no - 7605-WT, dtd the 20th July, 1965, Govt. of West Bengal Transport Department Notification No- 3363-WT/3M-34/99, dtd the 29th April, 1999 and Govt. of West Bengal Transport Department Notification No-813-WT/3M-80/2002 dtd, the 9th march 2012, I, Shri manoj Kumar Verma, IPS, Commissioner of Police, Barrackpore Police Commissionerate, do hereby issue the following orders of traffic restrictions to be implemented with immediate effect till further order:
